STEP by STEP Procedure for using BSNL Instpay Portal for Lease Circuit Bill Payment:

BSNL is offering facility to pay Lease Circuit bills through NEFT/RTGS based payment using Virtual Account Number (VAN) which will be allotted to customer once registered.

Each BSNL Lease Circuit account will be assigned a unique VAN.

Your Virtual Account Number will be like BSNLLC + (10-Digit of your account number) eg. BSNLLC1234567890

For availing the facility to use NEFT/RTGS payment following steps need to follow:

One time process includes below steps for getting Virtual Account number:

Step 1: Customer should Registration to the Instapay Portal

Step: 2 Login to Registered account

Step: 3 Virtual Account Number details and Profile information will be available

For doing the actual Online payment below steps will be executed:

Step: 4 NEFT/RTGS payment transfer should be made to the allotted Virtual account number

Step: 5 Receipt for the payment will be communicated through SMS/Email.

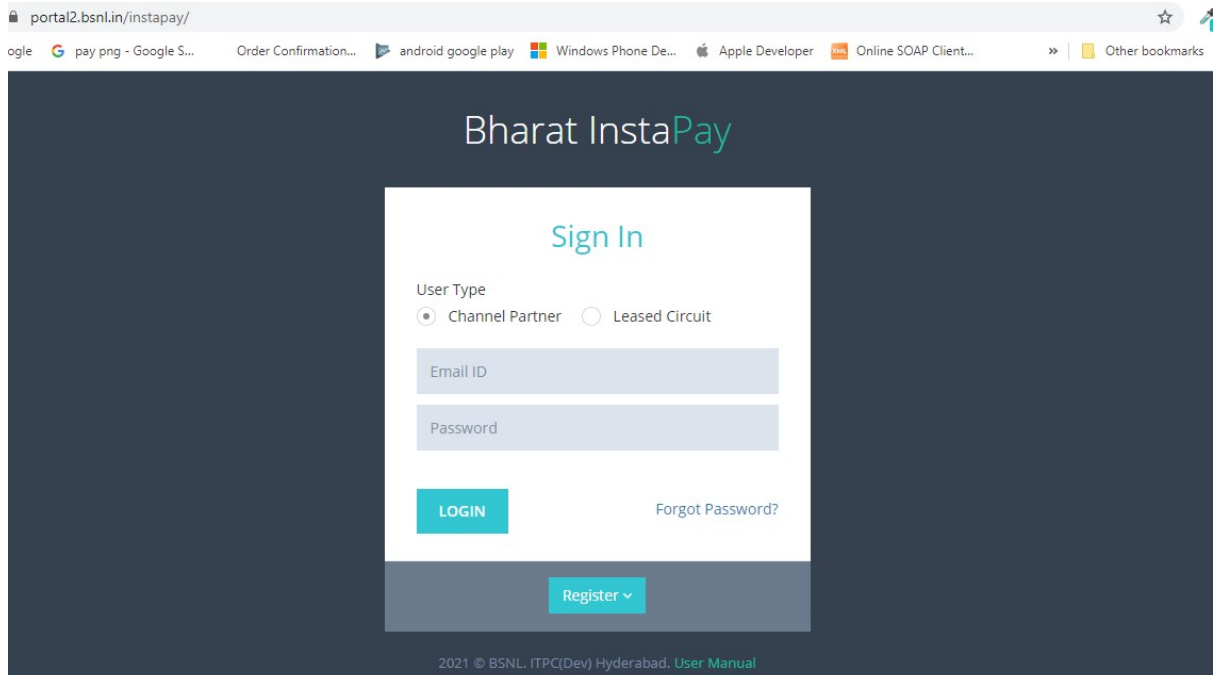
Step: 6 All the payment done can be monitored using Dashboard

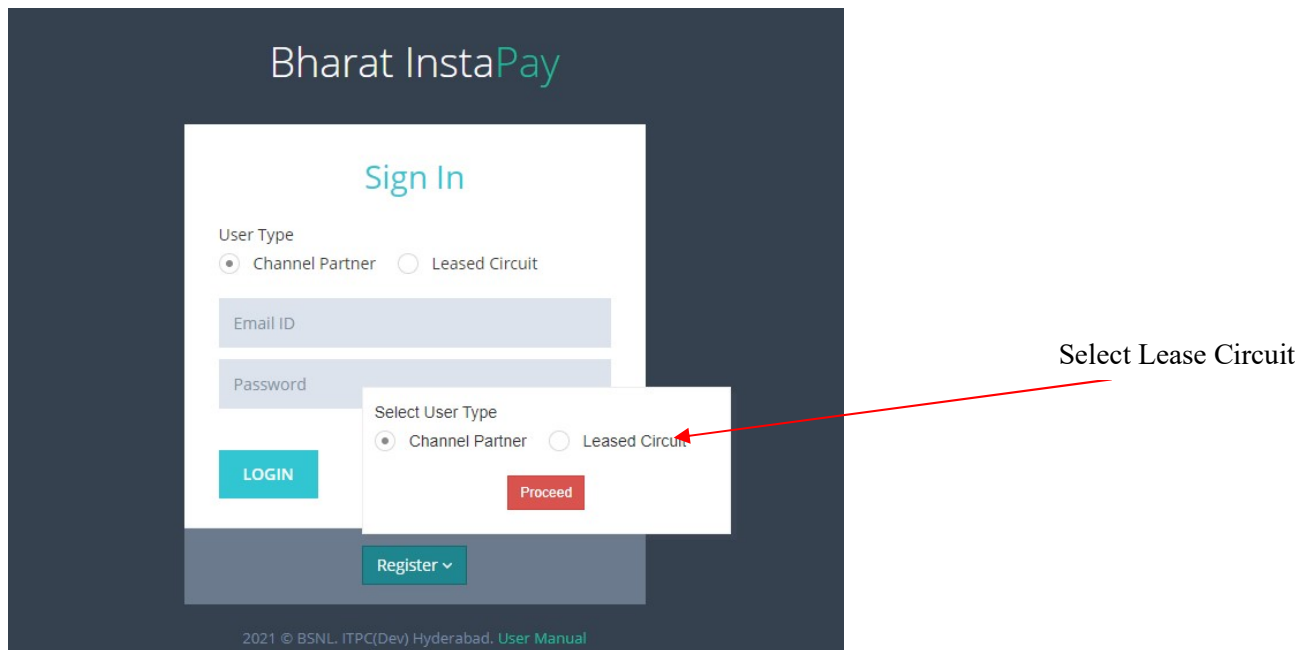
📌 Open the web browser in your desktop or mobile.

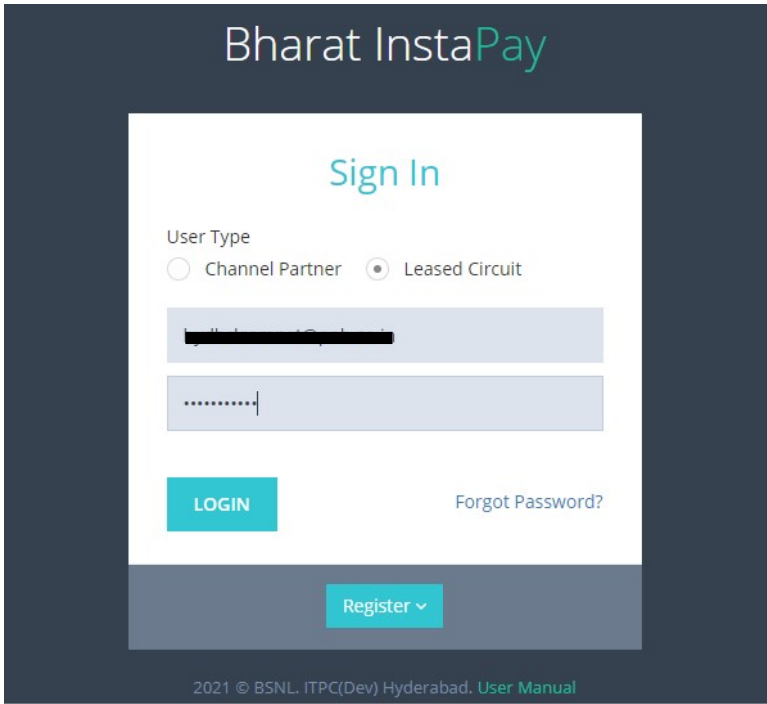

- ✚ Enter the received OTP to complete the registration.
- ✚ Registration success message will be displayed.

Dashboard gives below listed features to the users

- # Details required for making a RTGS/NEFT payment can be checked
- # All the NEFT/RTGS Bill Payment transactions can be viewed
- # Profile information of the registered users
- # Editing the profile information.
- # Changing the password.
- # Generating new password in case user forgets the password
- # Dedicated Account number information.

Important Points to remember:

- # Virtual Account Number will be of 16 digits. First four Digits will
- # be BSNL, followed by next two Digits as LC followed by 10 digit BSNL Lease circuit Account number
- # For Example For LC customer with account number 1234567890 the Dedicated Account number will be BSNLLC1234567890
- # Bill payment to be done using only NEFT / RTGS bank transfer to the registered VAN
- # Two bill payment transactions per day are allowed.
- # Amount transferred for payment should be equal to or less than bill amount
- # Once NEFT / RTGS amount transfer is done the amount will be credited to Lease circuit account as bill paid.
- # If for any reason the transaction is failed, the amount will be returned back to the source account from which transaction was initiated.

Steps for doing NEFT/RTGS Payment:

- ✚ User need to go to Bank page for doing the NEFT/RTGS Payment
- ✚ User should login to the Bank account using internet banking
- ✚ For the first time user need to Add Payee the details mentioned below to be used for adding Payee to the account
 - Beneficiary Name: BHARAT SANCHAR NIGAM LIMITED
 - IFSC CODE: SBIN0004266
 - Account Number: (Dedicated Account number shared after registration)
 - Type of Account: Current Type
- ✚ After successfully adding the Payee, user can make a NEFT/ RTGS amount transfer to the added Account.
- ✚ After successful payment, the amount will be credited as Bill paid for the lease circuit account.
